Ordinance No. 1993-4

AN ORDINANCE OF THE BOROUGH OF LILLY, CAMBRIA COUNTY, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE PROPER OFFICERS OF THE BOROUGH, ON BEHALF OF THE BOROUGH, TO EXECUTE AN AGREEMENT WITH TCI OF PENNSYLVANIA, INC., GRANTING A FRANCHISE TO TCI OF PENNSYLVANIA, INC., TO PROVIDE FOR CONSTRUCTION AND OPERATION OF A CABLE SYSTEM WITHIN THE BOROUGH OF LILLY AND FURTHER PROVIDING FOR REGULATION BY THE BOROUGH.

WHEREAS, TCI of Pennsylvania, Inc. (hereafter TCIPA) currently provides cable television service and other services via a Cable System located within the boundaries of Lilly Borough;

WHEREAS, TCIPA has submitted a "Cable System Informal Negotiating Proposal" in seeking renewal of permission to continue operation of said Cable System; and

WHEREAS, the Council of the Borough of Lilly has found the terms, provisions and conditions of said proposal to be acceptable and therefore desire to have such proposal become a binding Cable System Franchise Agreement through formal approval by the Council and acceptance by TCIPA.

It is THEREFORE ORDAINED and ENACTED by the Council of the Borough of Lilly, Cambria County, Pennsylvania, as follows:

SECTION I. - The Borough of Lilly hereby enters into a Cable System Franchise Agreement in the exact form and content as that copy that will be made a part of the minutes of the regular monthly meeting of the Borough of Lilly to be conducted on October 5, 1993 at 7:00 p.m. and which copy is, until said date, available at the office of the Borough of Lilly at 413 Cleveland Street, Lilly, Pennsylvania.

SECTION II. - The proper officers of the Borough are hereby authorized and directed, on behalf of the Borough, to sign and execute said Cable System Franchise Agreement, under the Municipal Seal of the Borough.

SECTION III. - All Ordinances or parts of Ordinances, Resolutions or parts thereof, permits or Licenses inconsistent or in conflict with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistency of conflict.

SECTION IV. - This Ordinance shall become effective immediately and the incorporated Cable System Franchise Agreement shall have a same effective date, pending acceptance by TCIPA.
