Revised General Ordinance For The Government Of The Borough Of Lilly.

Be it enacted and ordained by the Chief Burgess and Town Council of the Borough of Lilly, in the County of Cambria, and State of Pennsylvania, and it is hereby enacted and ordained by the authority of the same. That the following&the same is hereby enacted and ordained as for the Revised Ordinance for the Government of the said Borough of Lilly. To

Chapter I Auditors

The Auditors of the Borough shall meet annually in the second Monday in March, examine, Audit, and adjust the books, papers, and accounts of the Borough Treasurer for the proceeding year ending on the

second Monday of March.
Section 2. They shall cancell all orders or vouchers which are allowed by them in the settlement of accounts with the Treasurer and shall immediately make and present to the Council a writtien report of the receipts and expenditures of the Borough for the preceding year and also return to the Borough Clerk all orders or vouchers cancelled by them.

Chapter 2 Borough Property

Any person who shall destroy or injure in any way whatsoever any Public Property within the Borough shall, upon conviction, forfeit and pay for every such offense a fine of not less than five nor more than fifty dollars besides the amount of costs and expenses of repairing the same; provided, that when the injury is accidental no further fine shall be imposed than the amount of the expende of repairing the same. Section 2. Any person or persons who shall take or cause to be taken any sand, sod, or earth from any street, alley, square or land beloning to the Borough shall, upon conviction, be fined not less than one nor more than twenty dollars; provided that the said penalty shall not be imposed when taken in pursuance of a contract with the Borough. imposed when taken in pursuance of a contract with the Borough.

Chapter 3 Chief Burgess

Section I. The Cheif Burgess shall see that the Public Peace is preserved and shall enforce obedience to the Borough Laws and regulations and for this purpose shall have the control and direct the Police Force of the Borough he may from time to time call the attention of council to such subjects as he may deem proper to lay before them. Section 2. The Council shall fix the salary of the Cheif Burgess according to Law of the State of Pennsylvania. Section 3. The Borough Coucil shall have direct control of the appointment of all the Policemen of the Borough but the Cheif Burgess in case of an emergency shall power to appoint as many special policemen as the case in his judgement may require but no special appointment shall continue me learner than 48 hours without by order or consent of the council tinue no longer than 48 hours unless by order or consent of the council. Section 4. It shall be the duty of the Cheif Burgess to keep a correst account of all fees, fines, and costs received by him and he shall render a report to council at each regular meeting and shall pay all such money into the Borough Treasury.

Chapter 4 Borough Secretary

Section I. The Borough Sharetary shall have charge of the Borough Seal and shall affix the same to all documents requiring to be thus authentic-Section 2. The Borough Secretary shall draw orders on the Treasurer for the amount of all bills against the Borough which have passed Council and shall keep aregister of the same, he shall carefully file for preservation returns, papers, vouchers, and other documents of the Borough, he shall make out the diplicate for the use of the tax collector, he shall keep accurate accounts of all the outstanding liabilities of the Borough, and and annually in conjunction with the Treasure immediately after the Auditors settlement, make and submit to council a report of the financial condition of the Borough including a statement of receipts and Expenditures.

Chapter 4 Continued

Section 3. He shall record all ordinances passed by Council in a book to be keept for that purpose and perform other such appropriate duties as maybe required by Council; he shall keep correct minutes of the proceedings of Council and give due notice to the members thereof of any special meetings called by the Burgess; he shall see that all other ordinances and documents are signed by the proper officers and the seal affixed thereto, and generally perform such duties as are required of him by the Laws of the State of Pennsylvania.

Chapter 5 Council-Organization

Section I. On the first Monday in March in each year at 70 clock in the afternoon the Chief Burgess and the Councilmen Elect and those holding over shall meet at the usual place of holding meetings of council for the purpose of organization.

Section 2. At the same time the Chuef and the Councilmen Elect shall take the oath or affirmation of office as prescribed by law, and upon his of their to do so for the space off one month, Council shall unless otherwise determined by a majority of full Council declare the office vacant, and proceed to fill the vacancy or vacancies as required by law.

Chapter 6 Council-Meetings

Section I. A stated or regular meeting of Council shall be held on the fourth Monday evening of each Month but the Burgess when the interests of the Borough require it, or on the written request of three members of Council, shall call a special meeting of the same. At all meetings of the Council the President shall preside, and a majority of the members of Gouncil. The members of Council shall constitute a quoram; Seven o'clock in the evening shall be the time for calling each meeting of Council to the order for the transaction of business unless otherwise orde ered at a previous meeting or in the call of the special meeting. In the absents or iability of the Burgess to attend, a majority of the members may call a meeting of Council by written notice.

Section 2. At the first meeting of Council in each year they shall proceed to elect, viva voce, or by ballot the following Borough Officers in the order named Ist, Borough Secretary, who shallbe Clerk of Council, 2nd, Borough Treasurer, 3rd, Street Commisioner, 4th, Weighmaster, 5th, Policeman, 6th, Solicitor, each of said officers within ten days after his election shall take and subscribe to the oath or affimstion to discharge his duties with zeal and fidelity; otherwise his election or appointment shall be void abineto. ointment shall be void abineto. Section 3. The President of Council shall appoint such standing committees as the Council by resolution or order direct to look after and attend to such departments or portions of public business as the Council by resolution, or the President by order direct, which committees shall submit reports at all regular meetings of the of the business attended to by them respectively by them since the last meeting and also of the condition of the Public matters or business submited to their care.

Chapter 7 President of Council

Section I. In addition to the duties to be performed by the Bresident as herein other wise directed. The President of Council shall sign all orders, bonds, vouchers, and certificates of indebtedness drawn on the Treasurer for the payment of all such bills as have been approved and and directed by the Council to be payed and attested by the Borough Secretarty.

Chapter 8 Exhibitions

Section I. No person or persons not a citizen or citizens of the Borough shall exhibit within the limits thereof any theatrical or dramatical entertainment, or shall act, exibit, play or perform any opera circus, riding exhibition or horsemanship, menagarie exhibitione, panara, painting, sculpture, curiosity, trick, musical, party, concert or other entertainment, show or amusement for which money or other reward is demanded or recieved with out a license had and obtained and from the Chief Burgess; the price or tax to be recieved and charged by the Chief Burgess or by the Borough Officer designated by him shall not be less than two nor more than fifty dollars, the precise amount shall be determined by the Chief Burgess or the person he appoints to collect the same.

Section 2. For lectures on scientific, religious or literary subjects exhibitions or fairs, exhibitions of paintings or stationary given or made by the Citizens of the Borough, musical concerts or parties for the benevolent or charitable purposes, no license or permit shall be re-

quired.

Section 3. No person shall act, exhibit or show or perform in or cause to be acted, exhibited, or shown or per performed or to be in any manner concerned in the acting, exhibiting, showing or performance of any indecent, immoral, or blaphemous play, farce, opera, public exhibition, show or entertainment or performance of any kind whatsoever, nor deliver any lecture or discourse or hold any meeting likely to lead to the breach of the peace.

Section 4. Any person violating any provisions of this Chapter shall upon conviction thereof not be fined less than five nor more than fifty

dollars.

Chapter 9 Fines and Fees

Section I. All fines and forfietures under the provisions of any ordinance of the Borough shall be recovered by a summary conviction before the Chief Burgess and in all cases of conviction the party convicted shall be liable to pay in addition to the fine or forfieture the legal feesand costs which shall have been incured in the case.

Section 2. In the case of any persons sentenced by the Chief Burgess to imprisonment under any ordinance or regulation of the Borough or of any person who shall neglect of refuse to pay any fines that may be duly imposed on him by the Chief Burgess together with the fees and costs such persons shall be committed to the Borough lockup for the period not exceeding the time prescribed by law, and such fines fees and costs shall be codlected by due process of the law.

Section 3. All fees and costs charged by the Chief Burgess and policeman of the Borough shall be the same as for the Justice of the Peace and Constables of the Porough of Lilly in like cases. Section 4. If any person in any manner shall interfere with or bbstruct any officer or other person acting under the authority of the Borough in the discharge of his duty or shall resist the enforcement of any ordinance or regulatione of the Borough, such person shall, upon convictione, pay a fine not less than three nor more than twenty doll-

ars.

Chapter IO Policeman

Section I. It shall be the duty of the Policemen to enforce all Borough Ordinances or regulations, to make or cause to be made complaint to the Chief Burgess of all infractions of the same within their knowledge, to procure necessary proof thereof and in subordination to the Chief Burgess to preserve the peace and the quiet of the Borough; they shall quell all riots, tumults, and other disturbances.

Section 2. The Policeman designated by the Chief Burgess shall post or cause to be posted as prescribed by law all notices of elections held pursuant to any ordinance, resolution, or regulation of Council and all ordinances Enacted by the same, and if in any case council require personal notice to be given to the Policeman designated as the aforesaid shall give such notice; he shall also execute all warrants and processes issued by the Chief Burgess.

Chapter IO Continued

Section 3. If any officer of Policeman shall neglect or refuse to enforce any ordinance or regulation of the Borough after his attention has been called to any infraction there of by the Chief Burgess, or any Citizen of the Borough he shall be fined in asum not less than five dollares in addition to any other penalty to which he may be subjected by law for such neglect or refusal; and if such neglect or refusal shall be persisted in such officer or policeman may be dismissed.

Section 4. It shall be the duty of the Chiesf Burgess on the first Monday of March of each year to contact as favorably as possible with a policeman or other responsible person for the sustainance and care of parsons detained or imprisoned in the lockup under sentence by the Burgess, or awaiting trial, such contact to be submitted to Council at their next meeting for ratification, modification pr rejection.

Chapter 11 Nuisance

Section I. No person shall place or cast any earth, brick, stone, coal, mud, filth, ashes, water, lime, shavings, dung, or substances of any kind(except articles for the purpose of loading or un loading)Or storing away on any square, street, sidewalk, or alley within the Borough under a penalty of not less than one dollar nor more than ten dollars bedides the expense of removing the same if the same is removed by the Street Commissioner or any other Borough Officer providing that the section shall not apply to building material or other obstructions authoized by the Cyuneil nor to materials used in laying or repairing sidewalks, nor to the temporary replacing of scaffolding or ladders for the repairs of windows, shutters, roofs or repairing of building.
Section 2. No person or persons shall place his or her team, horse, mule, ass, gelding, carriage, dray, wagon, cart, or whatsower on any public Section I. No person shall place or cast any earth, brick, stone, coal, ass, gelding, carriage, dray, wagon, cart, or whatsowver on any public square, street, or alley withing the Borough limits between the hours of 8 P.M. & 6A.M. fo any day. Section 3. No person or persons shall place his or her wagon, dray, carriage, cart, team, horse, ass, mule, or gelding upon the streets, square, or alley within the Borough limits so as to interfere with public travel on the streets or sidewalks between the hours of 6AM & 8PM except for the purpose of loading or unloading not to consume more than an hour. Section 4. No team, horse, ass, mule, or gelding shall be permitted to stand more than two hours at any one time upon the streets, squares or alleys within the Borough limits-any person who shall violate any of the three preceing sections shall upon conviction forfiet and pay a fine of not less than one nor more than five dollars. Section 5. Any person who shall coast or slide with a hand sled down or across any thoroughfare, pavement, or sidewalk of the Borough shall upon conviction shall be fined not less than one and no more than five dollars. Section 6. The occupant or possessor of any lot within the Borough shall when required by notice of the Street Commissioner remove all wood, coal, ashes, bearels, boxes, or any other obstruction which may be with out legal authority on the sidewalks, square, streets, or allys in front of and adjoining the lots by such person from and off sidewalks, squares, streets, or alless and any person neglecting or refusing to remove the same shall pay and forfiet a fine of not less than one dollars foresch and over offense than five dollars for each and every offense. Any person who shall keep or suffer to remain upon his premises or private property carcas, garbage, offal, putrified meat, nauseaus liquor, or any person casting the same upon any lot or ground within the Borough limits, pr upon any of the streets or alleys therein shall be guilty of causing or maintaining a nuisance and shall be liable for the ex expense of removing same, and to a fine of not less than five and not more than twenty dollars.

Section 8. Every privy within the limits of the Borough shall be made close and private and be kept free from nauseaus and offensive smells to the neighborhood, and when any privy, vault, or sink for privy shall become offensive as aforesaid, the same is hereby declared a nuisance and the owner, occupier, or possessor of the same neglecting the correction or removing the said nisance after nitification from the Street Comissioner or other Borough Officer to do so shall forfiet and pay the sum of from one to ten dollars and shall also fofiet and pay for every week, the same is continued after said notice the futher sum of ten dollars.

Chapter 11 Continued

Section 9. No stove pipe shall project or extend through the side of end of a house, or through window or door of any house, shed, or building upon any lot, street, square, or alley on public grounds within the Borough, & all pipes, flues, and chimneys shall be carried up in a safe and secure distance not less than two feet so as not to be liable to set fire to the buildings, any persons violating the provisions herein contained shall forfiet and pay for every such offense a fine of one dollar and for every
week the offense may continue the further sum of five dollars.
Section 10. Any person who shall suffer or allow his swine, hog, pig,
sow, or shoat to run at large in the Borough shall pay a fine on conviction of such offense of not loss then one dollar non more than ten dollars. ion of such offense of not less than one dollar nor more than ten dollars, it shall be the duty of the Street Commissioner and police to sieze and impound any such animals so running at large and give information to the Chief Burgess of every such offense; if after four days the public notice of the taking up of any suchanimals the same is not claimed and the fine, costs, and charges for keeping, paid, it shall be sold at public sale to the highest and best bidder and the proceeds after deducting the fine and costs shall be paid to and remain in the hands of the Borough Treasurer subject to the call or order of the owner of such animal.

Section 11. Any person who shall engage in horse racing or who shall willfully ride or drive any horse, mare, gelding, or mule at a faster gait than a slow trot in or through any of the streets, alleys, bridges, or public grounds of the Borough shall be liable to a fine of not less than two nor more than ten dollars for each and every offense; providing that nothing herein contained shall apply to any officer in the discharge of his duty or when human life is in danger. Section 12. It shall be considered a common nuisance for any stallion or jack to be held ro suffered to cover a mare or jenny in public within the Borough limits; And the penalty for every such offense shall not be less than five nor more than ten dollars. Section 13. Any person who shall allow his horse, mule, or ass to run at large in the Borough shall pay a fine on conviction of such offense of not less than two and one half or more than five dollars. It shall also not less than two and one half or more than five dollars. It shall also be the duty of the Street Commissioner and Poice to seize and impound any such animals found running at large and to give infomation to the Chief Burgess of every such offense.

Section 14. The owner or pessessor of every dog or bitch within the Borough shall annually on or before the first day of November have the numbers and description of the dog or dogs owned by him registered with the Borough Police and shall pay a fee to the Tax collector for the use of the said Borough one dollar for every dog and two dollars for every bitch owned or possessed by him; It shall be the duty of the police who is authoized to make the foregoing registry to register all dog and bitches in the Borough at the time of the registry. es in the Borough at the time of the registry. Section 15. Nothing contained in the foregoing section shall authorize any bitch while in heat to run at large, but the owner oragent of such bitch or at whose house or premises the same may be allowed to remain shall securely and safely keep the same and prevent her from running at large but if no wwner can be found such bitch shall be killed, by the Section 16. Any persons violating the provisions of the two preceding sections shall forfiet and pay a fine not less than five nor more than te ten dollars, and any dog or bitch found running at large contrary to the provisions of said section is hereby declared a public nuisance, and the police or such person that the Burgess may appoint for that purpose shall kill and remove the same and shall recieve from the Borough a fee of fifty cents for killing and burying each dog.

Section 17. Any slaughter house within the limits of the Borough which by the reason of acummulation of offal or any other cause becomes obnoxious and offensive to any citizens of the Borough is hereby declared a Authority of the Chief Burgess. ious and offensive to any citizens of the Borough is hereby declared a public nuisance and the owner or occupier of the same, shall upon conviction thereof pay a fine not exceeding five dollars and for every week that the said owner or occupier of the same permits his slaughter house to remain in a noxious and offensive condition after he has been convicted before the Burgess he or they shall pay a fine not less thanone nor more than twenty-five dollars.

Chapter 11 Continued

Section 18. Any person who shall expose his person in public against the morality of the public, shall have been deemed a public nuisance and for every such offense shall upon conviction be fined not less than one nor more than twenty-five dollars.

Section 19. Each and every violation of any one or more of the sections of this Chapter is hereby declared a public and common nuisance and the person or persons guilty of such violation shall upon conviction pay the fines, costs and penalties imposed by the several sections repectively.

Chapter 12 Public Peace

Section 1. It shall be the duty of the Policeman at all times to apprehend all suspected night walkers, malefactors, vagabond, rogues and disorderly persons who may be found upon the streets, corners, or alleys or the sidewalks in front of public buildings; and further all persons having or carrying a concealed deadly weapon or weapons and gring such persons as may be apprehended before the Chief Burgess to be examined; and each of the such as the above described person as shall be deemed guilty of disorderly conduct calculated to diturb the peace or of being found gathered together in disorderly assemblage, shall upon conviction be fined not less than one dollar or more than ten dollars for each offense. Section 2. Any person or persons engaged in fighting, quarreling, or otherwise causing disturbances, or being intoxicated or guilty of drunkedmess within the Borough shall pay a fine of not less than one now more than twenty-five dollars.

Section 3. Any persons who shall within the Borough wilfully discharge any gun or firearms (except in necessary defense of self or property) or shall wontanly throw any metal, stone, brick, billet, or other missile or who shall explode any torpedo, bomb, or firecrackers in the streets or raise any false alarm of fire, shall for every such offense forfiet and pay a fine of not less than one nor more thanaten dollars in addition to any damage he may occasion or if any person shall mutilate, injure, or deface or destroy any fence, house, or gate within the Borough limits; such person for every such offense forfiet and pay a fine of not less than

one nor more than ten dollars.

Chapter 13 Licenses

Section 1. No person or persons shall be allowed to hawk or peddle any pictures, paintings, wares, goods or merchandise or sell the same on retail or on further delivery (and in case the person taking the orders fails to pay the license the party the person delivering such goods to be required to pay the same or subjected to the fine hereinafter mentioned) within the limits of the Borough until such person or persons shall have paid to the Chief Burgess for the use of the Borough a license fee of fifty cents for one day, one dollar for one month, two and a half dollars for three months, or five dollars for six months, or ten dollars for one year on so doing the person or persons shall be privileged to hawk or peddle in this Borough for the period designated by the license; when two or more persons are engaged in hawking and peddling the same articles the said tax shall be paid by on for each.
Section 2. No person shall use, or be upon any of the streets, lanes, squares, or public grounds of the Borough to hawk, or vend thereon any patent medicine, patented other article or thing in such manner as to collect any crowd or assembly of people without having first obtained a license frome the Chief Burgess, tha amount thereof shall be fixed by The Chief Burgess and shall not be less than fifty cents nor more than two dollars and fifty cents for each day.
Section 3. Any person offending against the provisions of the two preceeding sections of this ordinance shall upon conviction thereof be fined not less than three dollars nor more than ten dollars in addition to beingfrequired to pay the amount of the license required.

Chapter 14 Returns

Section 1. It shall be the duty of the Burgess, Weighmaster, Collector, Borough Secretary, and all other officials acting under the authority of the Borough who may recieve into their hands any of the funds of the Borough derived from fines, permits, rents, taxes, or from any other source whatever to pay to the Borough Treasurer on or before the first Monday of each and every Month the full amount received or collected by them respectively during the last preceding Month with statement of what source derived and to submit at the expiration of their term of office in each year a statement of all funds as derived paid to the Borough Treasurer.

Section 2. It shall be the duty of the Borough Officers or committie before contacting any debt to report to Council the amount of debt to be contacted and receive the sanction of Council, no debt or demand shall be received or paid by Council until this provision is Complied with.

Chapter 15 Sidewalks

Section 1. If any person or persons owning a lot or lots shall refuse or neglect to pave or repair his or their respective sidewalks or foot ways within twenty days after having recieved notice from the Street Commissioner to have the same done shall become the duty of the Street Commissioner to cause the same to be speedily done at the expense of the Borough whereupon the Chief Burgess shall proceed as provided by law to recover the amount so expended with ten percent added thereto as penalty for such neglect or refusal, which sum or sums shall be paid into the Borough Treasury for the use of the Borough.

Section 2. No opening, railing, or passageway into cellars not made previous to August 15th 1883, shall be allowed to extend more than one foot upon any street or alley of the Borough. All the cellarways with out an exception shall be securely covered and protected with a door or doors to shut even with the sidewalks nor shall any step or steps, signs, purches or other like projections or obstructions be allowed to extend over or occupy more than one foot of the sidewalk from the inner of bl building line thereof under a penalty of not less than two nor more than ten dollars and every continuance thereof for more than one week after the first convictione shall constitute a fresh offense.

Section 3. All cellar doors or passageways from the sidewalks down to the shall be safely closed kept after nightfall and until daylight, any violation of this section shall be under apenalty of not less than one or more than ten dollars.

Section 4. Any person propelling any bicycle, cart, or wheelbarrow over or upon any sidewalks in the Borough (except for the purpose of loading or unloading) shall be liable of a fine not less than one or more than

Chapter 16 Streets and Alleys

Section 1. The pavement or sidewalk of every street in the Borough shall have a width of not less than four feet measuring from the Building line to the curb stone.

Section 2. Any lamp, awning, signpost, shade, or ornament tree planted or placed along any such pavement or sidewalk shall be deemed and sonsidered a common nuisance unless the same be placed or planted in or along the line of the curbstone of such pavement or sidewalk; any person violating the provisions of this section shall be subjected to afine of not more than ten dollars in addition to the expenses of removing the same. Section 3. If any person shall wilfully or wantonly cut bown or injure any ornamental shade or fruit tree, lamp, sign, or awning post legally planted or placed on any sidewalk or pavement of the Borough, or on public or private ground such person shall be liable to a fine of not less than five dollars.

Section 4. That all the poles new settup in said Borough or any erected

three dollars.

Section 4. That all the poles now settup in said Borough or any erected hereafter shall be placed near the curbline of sidewalk and shall be placed thereat and under the supervision of the Street Commissioner.

Chapter 17 Street Commissioner

The Street Commissioner shall be in subordination and subject to the direction of the Council and shall have full power and authority in sarrying out their instructions or the enforcement of ordinance to make contacts he shall hire all needfull aid subject to the approval and confirmation of the Council. Section 2. The Street Commissioner shall give immediate notice to all persons whose buildings, fences, or other improvements enroached upon the public sidewalks, streets, or alleys to femove the same forthwith; also to notify all persons whose platforms, steps, railings, signs, cellar openings or door-passage-ways enclosures, bulk or jut windows, porches, or jams, or any other similar obstructions are made or placed in which may hereafter be made or placed in violation of the ordinance of the Borough, to remain, close up, or change in conformity with the ordinances all such obstructions, and if the same be not done within twenty days from and after such notice it shall then become the duty of Street Commissioner to remove without delay the expense of the Borough all such buildings, fences, or other improvements and all such passageways or openings to be closed up whereupon the Chief Burgess in addition to any fine which may be imposed according to the ordinance of the Borough shall proceed as povided by law to recover the amount so expended by the Borough for the removal of any such obstructions hereinafter specified with ten per centum added thereto which sum or sums shall be paid into the Treasury for the use of the Borough.

Section 3. It shall be the duty of the Street Commissioner to enforce all regulations or ordinances relating to streets. all regulations or ordinances relating to streets, alleys, or sidewalks, gutters, sewers, culverts and bridges, and attend to the opening all new streets and alleys and to see that public highways are kept in good condition and free from all obstructions and nuisances and that all gutters, sewers, culverts or other waterways are kept freekand open, and that no stagnant water is permitted to gather or remain within the Borough limits whether on public or private ground, and further it shall be his duty to see that persons attend strictly to placing thier pavements, fences, buildings or improvements of whatever natur upon the correct grades or lines, he shall also see that all persons occupying any parts of streets alleys, or public squares for building purposes, have thier proper per-Section 4. To carry into effect the foregoing section sthe Street Commissioner shall at least once in each and every month go through the various parts of the Borough and examine for and ascertain if any violation of the ordinances of the Borough relative to sidewalks, streets, or alleys has been done or committed and to see that all ordinances on the execution and fulfillment of which depend the health, cleanliness, good order and safety of the orough from fire are faithfully obeyed and complied with and shall immediately give imformation to the Chief Burgess of the puisances, violations, or ommissions which he may have a discovered mits from the Chief Burgess. the nuisances, violations, or ommisions which he may hav e discovered whereupon the Burgess shall prodeed forthwith to enforce the proper fines and penalties. The Street Commissioner shall full power and authority to Section 5. enter into and upon any lot at the expense of the owner or occupier of the same or any or all common nuisances, but before proceeding to do any removing of such nuisances, he shall have given the owner or occupier of the lot house or private property in or upon which the said nuisance is situated, notice of not less than three hours, nor more than forty-eight hours in which to abate the nuisance.

Section 6. The Street commissioner shall see that all loss stones are kept off the streets, and have all stones used in repairing streets broken fine.
Section 7. The Street Commissioner shall certify all bills furnished in his department, and have charge of all tools and implements belonging to the Borough and be accountable for the same, and at the close of his term of office render to council an itemized inventory of all such property in his possession and it shall be his duty to keep an accurate account of all appropriate where and for what purpose expenditures in his department and designate where and for what purpose expended.

Chapter 18 Treasurer

Chapter 18 Treasurer

The treasurer before entering upon the duies of his office Section 1. shall give bond with surety in such manner as the council shall designate the surety to be approved by council and the bond to be filed with the Borough Secretary.

Section 2. He shall recieve all moneys accruing to the Borough And shall pay the same out only upon orders of the President of the Borough Council and countersigned by the Borough Secretary, and for the redemption of bonds, coupons, andcertificates of the indebtedness of the Borough when the the same are due and payable and shall deliver to his successor in office any books, money or property belonging to the Borough in his possession or control.

Section 3. He shall cause the accounts of his office to be kept in an intelligible manner wherein the reciepts and expenditures shall be exhibited; and the particulars of each item, of charge and discharge shall correctly appear; and said account shall be open at all times to the inspection of the Chief Burgess or any member of Council. Section 4. He shall when required to do so by the Borough Auditors produce his books, papers, vouchers, and accounts; and aid the Additors in making a settlement of the Borough accounts.

Chapter 19 Weighmaster and Scales

It shall be the duty of the Weighmaster to weigh all hay, Section 1. coal, or live stockand such other articles or things as may be presented for that purpose at the weigh scales of the Borough; and to furnish a proper and numbered certificate of the quantity in weight or bushels of the article or thing weighed; and when the name of the purchaser be ascertained his name shall be inserted in the certificate. Section 2. No person shall be permitted to sell or deliver anhhay or coal within the limits of the Borough in carts, wagons, sleds, or other vehicles until the same shall have been weighed upon the Borough scales and the number of pounds or bushels as the case may be duty ascertained by the weighmaster, and if any paerson shall sell or recieve payment of any load of coal or hay not so weighed and the weight or bushels not so ascertained, or before recieving a ticket thereof from the weighmaster or having recieved such certificate shall sell or receive payment for such load on part of it without delivering the certificate to the purchaser, such person or persons shall be liable to a fine not less than one nor more than twenty dollars for such offense.

∠ Section 3. It shall be the duty of the weighmaster to keep the Borough sc scales in good order and repair, if mud, dirt, or other extraneous substances shall adhere to any vehicle weighed, it shall be his duty to make an estimated deduction on account thereof and also for any undue moisture in hay or any other articles weighed. If any paerson shall present or make use of a false certificate or one user on some other load than that on which it is fruadulently used he shall upon conviction, pay a

fine of not less than five nor more than twenty dollars. Section 4. There shall be charged and collected by the Weighmaster for each and every draft made by him on the Borough scales the following sums to Wit: for each and every load of straw 1000 lbs. or less 20 cents, exceeding 1000 lbs. 25 cents, for each and every load of coal of 2300lbs. 16 cents, for each and every load of coal over 2300 lbs. 15 cents, for each and every load exceeding 3000 lbs. 20 cents, for weighing cattle, sheep, and hogs per hundred lbs., (provided no draft shall be madefor less than 15 cents), one cent; for all drafts not above enumerated of 2000 lbs. or less each 10 cents: for all drafts not above enumerated 2000 lbs. or less each 10 cents; for all draftes not above enumerated

exceeding 2000 lbs, 15 cents.

Section 5. The weighmaster shall within ten days after his election give bond with security to be approved by Council in such sum as they shall designate, conditioned for the faithful performance and discharge of his duties, and to pay over to the Borough Treasurer at least once in each and every month all moneys belonging to the Borough; and to make a complete statement at the expiration of his term; and to turn over to his successor all moneys or papers which may be in his possession.

ORDINANCE I Chapter 20 Solicitors Section 1. The Solicitor shall be the legal advisor of the Borough officers in all legal matters pertaining to their official duties; He shall furnish his proffessional opinion on all legal points that may be referred him for that puppose by council; shall prrosecute and defend all suits, actions in law or equity to which the Borough is a party and generally have charge and contol of all legal business of the Borough. Section 2. For the faithful discharge of his duties as solicitor he shall recieve such compensation as council may by resolution direct. Chapter 21 Stables and Barns Section 1. No person shall erect any stable or barn within twenty feet of any street in the Borough; any person violating the provisions of this ordinance shall forfeit and pay a fine of not less than twenty and not more than one hundred dollars, and if any person buildsor erects a stable or barn in violation of the provisions herein contained and fails to remove the same within ten days after recieving notice to that effect from the Street Commissioner or other Borough Officer, he shall forfeit and pay for every week the same is permitted to remain the further sum of ten dollars. Chapter 22 Repealing Conflicting Ordinances Section 1.. All ordinances or parts of ordinances in sonflict with the foregoing be and the same are hereby repealed.
