ORDINANCE 2

Adopting And Naming Certain Streets And Alleys In The Borough Of Lilly As Public Highways Thereof And Fixing The Width Of The Same.

- Section 1. Be it enacted and ordained by the Burgess and the Town Council of the Borough of Lilly in the County of Cambria and the State of Pennsylvania and it is hereby enacted and ordained by the authority of the same:— That the following named and described streets and alleys be and they are hereby adopted as and declared to be public highways as streets and alleys respectively of the Borough of Lilly and the with thereof shall be as hereinafter set forth to Wit:—
- Section 2. All that street or part of street commencing at a line in the center of Railroad Street opposite the property of Philip Pritch and extending north easterly to Bear Rock Run and thence notherly to the Borough line shall be known as Main Street and the width thereof from Railroad Street to Pennsylvania Railroad "Y" shall be forty (40) feet and from the "Y" to the Borough line the width shall be fifty (50) feet.
- Section 3. All the Street or part of street commencing at Railroad Street at corner of properties now or lately of Caron Leahey and
 extending easterly to Portage Street shall be the width of forty (40) feet.

 KNOWN-AS-CLEVELAND-STREET
- Section 4. The street or part of street beginning at Main Street at corner of properties of Dr. F.C. Kress and Robert Smith, and extending westerly to aline on the Township Road (now Cemetary Street) near the Borough line shall be known as Church Street, and the width thereof shall be thirty (35) five feet.
- Section 5. The street or part of street commencing at Main Street at corner of prperties of M.L. Yingling and Wm H. Piper and extending easterly to a point on Portage Street shall be known as North Street, and the width thereof shall be forty (40) feet.
- Section 6. The street or part of street commencing at Railroad Street and conner of properties of John Mc Cool and Mrs. Caroline Mtezgar and extending easterly to Potage Street (the same having been formerly been a Township Road) shall be known as Washington Street and the width thereof shall be Thirty-five (35) feet.
- Section 7. The street or part of street commencing at the southerly terminus of Cemetary Street and extending easterly to the Borough linecrossing the Railroad, intersecting with Railroad Street and crossing Portage Street shall be known as Grant Street, and the width thereof shall be thirty-five (35) feet.
- Section 8. The street of part of street commencing at the westerly terminus of Grant Street and extending northerly, passing the cemetary and intersecting with Church Street, to the north Borough line shall be known as Cemetery Street and the width thereof shall be thirtyfive (35) feet.
- Section 9. The street or part of street commencing at the south Borough line and extending northerly across Grant Street and intersecting with Washington, Cleveland, and North Streets, and also crossing Bear Rock Run, shall be known as Portage Street and the width thereof shall be forty (40) feet.
- Section 10. The street or part of street commencing at line of Grant Street, opposite of what was formerly known as Hamilton's Grocery, (said street having been formerly laid out as a Township Road), and extending northerly, intersecting with Main, Washington, and Cleveland Streets and crossing Church Street to the Borough line shall be known as the Railroad Street and the width thereof shall be thirty-five (35) feet.
- Section 11. The street or part of street commencing at Portage Street at corner of properties of Joseph H. Moyerestate and Albert George estate and extending easterly to the Borough line shall be known as Piper Street, and the width thereof shall be forty (40) feet.

- Section 12. The street or part of street commencing at Piper Street at corner of property of John Leahey Jr. and John Backsater and extending south to William Street shall be known as Harris Street and the width thereof shall be forty (40) feet.
- Section 13. The street or part of street commencing at Cleveland Street and corner of property of Thomas Leahey and Mary M. Leahey, and extending norterly to North Street shall be known as Willow Street and the width thereof shall be forty (40) feet.
- Section 14. The street or part of street commencing at Cemetary Street and corner of property of John Conrad and Pennsylvania Raidroad land; and extending southerly and then westerly to the Borough line shall be called as Wood Street, and the width thereof shall be thirty-five (35) feet.
- Section 15. The street or part of street commencing at Wood Street at corner of properties of John Conrad and extending southwesterly to the Borough line shall be known as Jefferson Street, and the width thereof shall be thirty-five (35) feet.
- Section 16. The street or part of street commencing at Portage Street at corner of properties of M.M. Leahey and Albert George Estate and extending easterly to the Borough line, shall be known as Jones Street and the width thereof shall be thirty-five (35) feet.
- Section 17. The street or part of street commencing at Church Street at corner of properties of Joseph Rainey and August Yingling and extending notherly to the Borough line shall be known as George Street and the width thereof shall be thirty-five (35) feet.
- Section 18. The street or part of street commencing at Church Street at corner of properties of Thomas W. Ryan and M.E. Leahey and extending northerly to the Borough line shall be known as Barker Street and shall be the width of Thirty-five (35) feet.
- Section 19. The street or part of street commencing at Church Street at corner of properties of Thomas W. Ryan and JOhn Maxwell and extending northerly to the Borough line shall be known as White Street and shall of the width of (35) feet.
- Section 20. The street or part of street sommencing at Church Street at corner of property of E.J. Hughs and Cemetery Street extending northerly to Borough line shall be known as Sechlar Street and the width thereof shall be thirty-five (35) feet.
- Section 21. That the alley commencing at the P.R.R. "Y" lying between Railroad and Main Streets and extending southerly to a line in the center of Spruce Alley shall be known as Chestnut Alley and the width thereof shall be fifteen (15) feet.
- Section 22. That the alley commencing at Railroad Street at corner of property of M.M. Leahey and extending easterly to Chestnut Alley shall be known as Spruce Alley and shall of the width of nine (9) feet.
- Section 23. That the alley commencing on Main Street at corner of property of F.C. George, and extending westerly to Railroad Street shall be known as Hickory Alley and the width thereof shall be ten (10) feet.
- Section 24. The alley commencing on Washington Street at corner of property of Gephart Bender Estate and extending northerly to Cleveland Street, shall be known as Walnut Alley and the width thereof shall be twelve (12) feet.
- Section 25. The alley sommencing on Washington Street at sorner of property of Gephart Bender Estate and extending northerly to Cleveland Street shall be known as Willow Alley and the width therof shall be fourteen (14) feet.
- Section 26.
