

## ORDINANCE 19

An ordinance of the Borough of Lilly, County of Cambria, and State of Pennsylvania: Providing for the laying out and opening of Ridge Alley in said Borough

-----

Be enacted and ordained by the Town Council of the Borough of Lilly, County of Cambria and State of Pennsylvania and it is hereby ordained by the authority of the same, that the alley herein after devised and be known as Ridge Alley be and the same is hereby laid out and directed to be opened as a public highway of said Borough, the description of the proposed Alley by metes and bounds being as follows:

Beginning at a point in Portage Street ninety-nine feet east of the intersection of Portage Street with Washington, thence north fifty-nine degrees twenty-two minutes west one hundred and four tenths of a foot along land of John Leahey to the point in the other land of said John Leahey in line of old public road; thence by land of John Leahey south forty-three degrees twenty-three minutes west one hundred and five feet and one tenth of a foot to point in land of W.H.Piper and Company; thence by land of W.H.Piper and Company the same course ninety-two feet to a post; thence south thirty-four degrees twenty-seven minutes west eighty-four feet to a point in land of F.L.George same course one hundred and twenty-seven feet and four tenths of a foot to a point on land of L.M.Sanderson; thence by same course through land of M.M.Sanderson thirty-one feet to a post; thence through land of M.M.Sanderson south seventy-seven degrees fifteen minutes west thirty-three feet and twenty-five one hundredths of a foot to a point in land of F.C.George; thence through land of F.C.George same course twenty-four feet to a post; thence through land of F.C.George south fifty-six degrees eleven minutes west one hundred and fourteen feet and four tenths of a foot to a post; thence through same course eighteen feet and eight tenths of a foot to a post on the north side of Main Street near county bridge; said point being south thirty-one degrees fifty-six minutes west fifty-six feet and ninety one hundredths of a foot distant from a monument on the north side of Main Street and on the west side of county bridge crossing Bear Rock Run; thence distance of seventeen feet in a easterly direction along Main Street to a point; opposite side of proposed alley; thence through land of F.C.George north seventy-eight degrees forty-three minutes west thirty-three and two tenths of a foot to a post; thence through same north fifty-six degrees eleven minutes east one hundred and fourteen feet and six tenths of a foot to a post; thence through same north seventy-seven degrees fifteen minutes east thirty-five feet to a post in line of L.M.Sanderson same course twenty four feet and seventy-five one hundredths of a foot to a post; thence through land of same north thirty-four degrees twenty-seven minutes east eight feet to a point on land of John McGraw sixty-six feet to a post of Charles T.Sell thence through land of Charles T.Sell same course sixty-one feet to a point in land of W.H.Piper & Co.; thence same course through land of W.H.Piper & Co. eighty feet to a post; thence through land of same north forty three degrees twenty-three minutes east ninety-six feet to land of James Rainey; same course forty-two feet to land of Mrs. Evans; thence by same course of said Mrs Evans fifty-two feet to a post; thence by land of Mrs Evans fifty-nine degrees twenty-two minutes east eighty nine feet and six tenths of a foot to a post on south side of Portage Street in a westerly direction twelve feet and five one hundredths of a foot to a post the place of beginning.

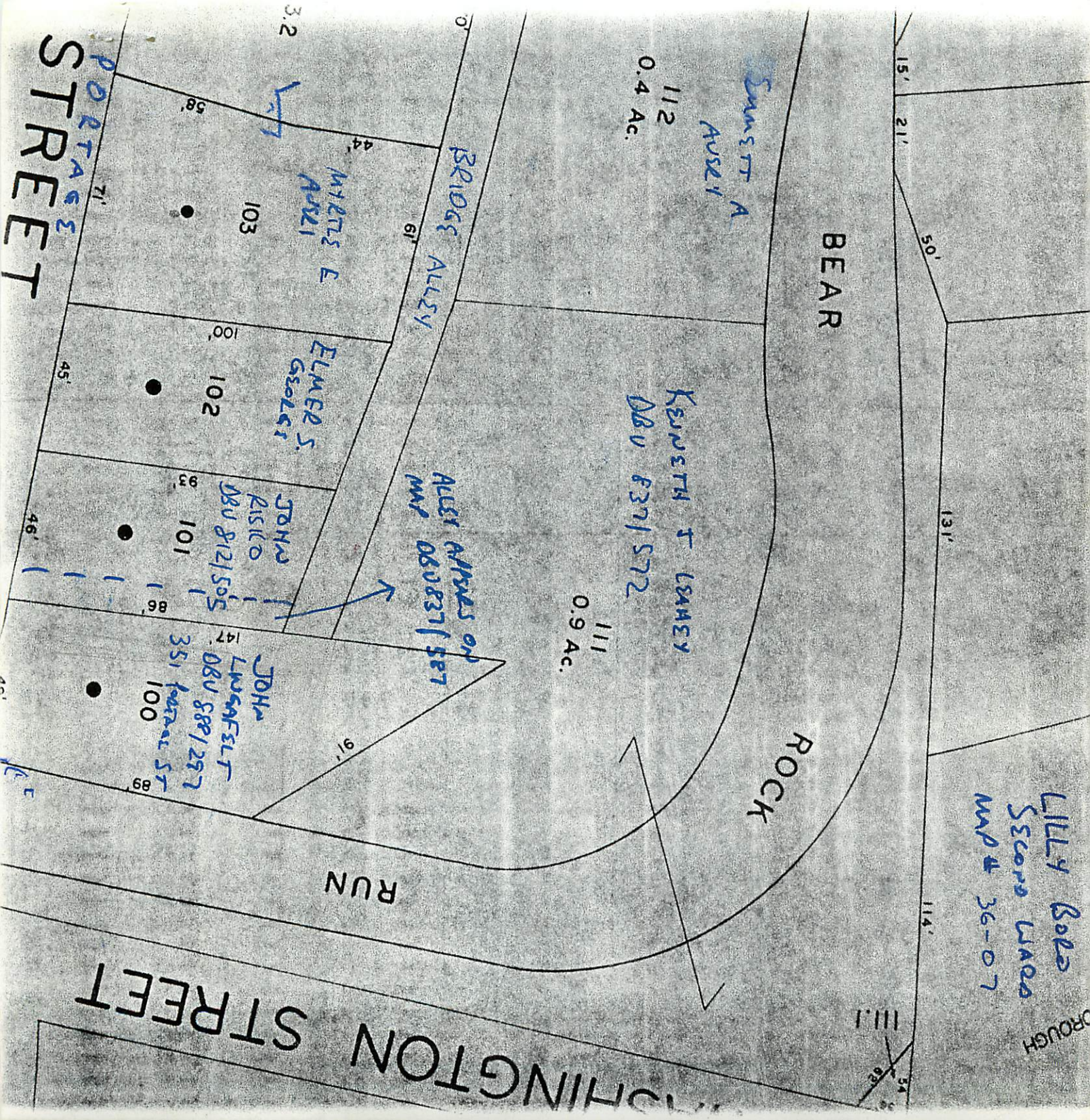
