Ordinance 21

Providing for the the regulation, method and manner of laying sewers, sewage, mains and cost of taps from small mains into curbs of adjoining property owners and providing for payment of same.

Section 1. Be it ordained by the council of the Borough of Lilly County of Cambria, And State of Pennsylvania and it is hereby ordained by authority of the same; that from the date of passing of this ordinance the cost of placing sewers and sewage pipes in the aforsaid Borough of Lilly, shall be on the the date if passing of this ordinance the cost of placing sewers and sewerage pipes in the aforesaid Borough of Lilly, shall be on the foot front plan as follows all property owners on bothe sides of the street, shall pay into the Borough Treasury within (60) days from the date the sewersare laid in the streets in front of thier property One dollar (\$1.00) for every foot front of thier respective properties. That abut in said street, proving however that were a property owner may own property that is located on a corner, and thus if property abuts on both streets he may have an option of paying a sum that will pay for the foot front that is on the most narrow party but in case a property owner may desire to tap the sewer running on both streets that pass his property, then he must pay for the foot front that may be on both streets running past his property.

Section 2. The Borough of Lilly must lay the main sewers on the street and must make the tap into the main sewer and lay pipes from the main sewer up to the curb of the property owners and the above sum of one dollar (\$1.00) per foot front shall be due from the property owners whether they take advantage of the sewers or whether they do not take advantage of it i.e. whether they tap or not.

Section 3. Those property owners who now have the sewer in front of their properties, but who have not taken advantage of the sewer shall be compelled to pay the above rates one dollar (\$1.00) foot front and after the date that the Borough of Lilly see fit can make a tap into the main sewer and can place up and to the curb of said property.

Section 4. The method of collection for this money due from property owners for sewers and laying of sewerage lines shall be as provided by statutes of other municipal lieus in Boroughs of this Commonwealth

Section 5. Any ordinance or part of ordinance conflicting with the provisions of this ordinance be and the same is hereby repealed, so far as the same effects this ordinande.
