ORDINANCE 26

An Ordinance Regulating Traffic In The Borough Of Lilly.

Be it enacted and ordained by the Town Council of the Borough of Lilly, and it is hereby enacted and ordained by the authority of the same that the following regulations shall apply to the operation of all vehicles in the Borough of Lilly:

Definitions:

- (A) The word "highway" shall mean the whole width from property line to propertyline of the street, alley, avenue, bridge or other place intended, used or set apart for the public, including sidewalks, curb, street of other intervening space therein.
- (B) The term "street" shall apply to that part of a highway intended for vehicles.
- (C) The term "curb" shall apply to the boundaries of a street.
- (D) The term "horse" shall apply to any draft animal of Beast of Burden.
- (E) The term "vehicle" shall apply to all automobiles, trucks, and any horse drawn mode of conveyance, and shall not apply to an invalid chair or a childs conveyance
- (F) The term"driver" shall apply to the leader, rider, or driver of a horse to a person who pushes, draws, propels, operates or who is in charge of a vehicle.
- (E) The term "parked" shall apply to a waiting vehicle and to waiting vehicles drawn up alongside of one another, not parallel to the curb
- Clause (a) A vehicle meeting another shall pass to the right, a vehicle overtaking another shall pass to the left and not pull over to the right untill clear of it; a vehicle turning into a street to the right shall turn the corner as near the right hand curb as practiable; a vehicle turning into a street to the left shall pass around the point of intersection of the two streets.
- Clause (b) A vehicle crossing from one side of the street to the other shall do so by turning around in the direction the traffic is going; a vehicle shall keep as near as practicable to the right hand curb so as to leave the center of the street clear for overtaking traffic, the slower the speed the nearer the curb. A vehicle shall not back to make a turn if it obstructs traffic, but shall go around the block or to a street wide and clear enough for the purpose. A vehicle shall not follow another too closely for safety a vehicle shall not stop with its left side to the curb.
- Clause (c) No vehicle shall emerge from an alley, stable, garage, or other area of building abbutting on a side walk at a pace faster than a walk; a vehicle shall not stand so as to prevent free passage of other vehicles in both directions.
- Clause (d) The driver of every vehicle before turning the commer of any street, turning out or starting from or stopping at a curb line of any street shall see that there is sufficient space free from other vehicles so that such turn, stop or start may be safely made and then shall give a plainly audible or visible signal.
- Clause (e) No vehicle shall stand within ten feet of a fire plug and no vehicle shall pass over any fire hose while the same is being used at a fire. No vehicle shall be permitted to stand less than twenty feet from a intersection of any street.
- Clause (4) When two or more vehicles shall arrive at a street intersection at the same time, the vehicle to the right hand of any driver shall have the right away.
- Clause (g) No vehicle shall stand upon any highway within the Borough while the lepenatore partany agent of the operator or owner solicits passengers for hire; provided that certain streets, alleys, or public places maybe designated by the Council with the approval of the Burgess as stands for which such vehicles for hire.

- Clause (h) The unmessary sounding of signals or blowing of horns on standing vehicles is hereby prohibited. The use of a muffler cut-out is prohibited. Dense smoke from motors is prohibited.
- Clause (i) From one hour after sunset to one hour before sunrise all motor shall show two white lights in front, except that motorcycles shall have one white light in frontand a red light in the rear. The lights in front shall not be excessive in intensity and shall not give forth a degree of luminosity greater than is necessary to proceed safely within the speed limits.
- Clause (j) No person shall operate a motor vehicle while intoxicated or ata greater speed than is reasonable or proper, having regard to the use of the highway or so as to endanger the property, life or limb of any person and in no case shall a motor vehicle be operated at the rate of speed greater than one mile in four minutes. In no case shall a horse be driven or ridden at a speed greater than eight miles and hour.
- Clause (k) No person shall place or cause to be placed upon any highway within this Borough any vehicle or horse and permit the same to remainat any time for more than the period of time herein after mentioned; vehicle without animal twelve hours; horse five hours provided that the same shall not be placed on hitched on main street for a period longer than one hour at a time.
- Clause (1) No person shall stop any vehicle or horse on any of the street crossings or intersection or obstruct the same in any manner. No person shall cause or permit any horse to stand upon the highway of this Borough unless the same is securely fastened to post or other hitching place.
- Clause (m) All vehicles, animals, materials and things on the highways of this Borough contrary to the provisions of this ordinance are declared to be nuisances, and the same may be removed by the proper officer of the Borough. Any person or persons violating any of the provisions of this ordinance shall be deemed guilty of a misdemeaner and upon conviction thereof, shall be sentenced to pay a fine of not less than three (\$3.00) dollars and not more than thirty (\$30.00) dollars.
