

ORDINANCE 47

An ordinance providing for the extending, laying out and opening of Chestnut Alley in the Borough of Lilly from Chestnut Alley Easterly to Main Street.

Section 1. Be it enacted and ordained by the Burgess and Town Council of the Borough of Lilly, and it is hereby enacted and ordained by the authority of the same, that Chestnut Alley in the Borough of Lilly shall be extended, laid out and opened as a public Alley and highway from its present terminus at the westerly side of Bridge Street in an easterly direction so as to intersect with Main Street according to the following courses and distances, to-wit: Beginning at Chestnut Alley two (2) feet from the northerly corner of the store room originally of L.M.Sanderson; thence along Chestnut Alley north thirteen (13) degrees and seven (7) minutes east a distance of ten (10) feet; thence south seventy-five (75) degrees and twenty-one (21) minutes east through the land now owned by the Borough of Lilly; thence through the land of Illig Brothers one hundred and nine (109) feet, more or less on a point in Main Street; thence south fourteen (14) degrees thirty-nine (39) minutes west along Main Street ten (10) feet to a point; thence north seventy-five (75) degrees and twenty-one minutes west through the land of Illig Brothers and along the line of land of L.M.Sanderson a distance of one-hundred and nine (109) feet to Chestnut Alley.

Section 2. That the width of said alley shall be ten (10) feet according to the lines shown on the map or plot of the said extension of Chestnut Alley made by P.F.Campbell, Borough Engineer, dated the eighteenth day of December, A.D., 1926.

Section 3. That all the land lying within the said ten (10) feet as mentioned and described in this ordinance, to-wit:-the section approximately one hundred and nine (109) feet in length and ten (10) feet in width lying between Main Street and Chestnut Alley, said land being in the name of Illig Brothers and the Borough of Lilly, be and the same is hereby taken, appropriated and set apart for public use as an alley or highway of the said Borough of Lilly.

Section 4. That all ordinances and regulations of the Borough of Lilly heretofore enacted and applicable to the alleys and highways thereof, be and the same are hereby extended and applied to the said Chestnut Alley as herein extended.

Section 5. That all ordinances or parts of ordinances inconsistent herewith, be and the same are hereby repealed.
