## ORDINANCE 48

Expressing a desire of Council of the Borough of Lilly to purchase the plant and domestic system of the Summit Water Supply Company, in its entirety, including the puping system in the Borough and immediately adjacent thereto, which is used in distributing water to domestic consumers in the Borough of Lilly at the present time; the intake on Bear Rock Run, and the pipe line main leading therefrom to the Borough of Lilly for a price of Forty Thousand (\$40,000.00) Dollars.

Subject to the approval of the Public Service Commission of the Commonwealth of Pennsylvania and to the further condition that the Summit Water Supply Company, will, when the supply of water from the Bear Rock Run intake is inadequate for the Borough of Lilly, furnish such quantities of water as may be necessary to make up the defecienty from Bear Rock or other Main Pipe line and the Borough to pay for this emergency supply of water at the rate of twenty cents per thousand gallons, and also, to the further condition that the Summit Water Supply Company to maintain a connection to their Bear Rock Main and install a meter, at the expense of the Summit Water Supply Company, the Borough to bear the expense of the pipe line leading from the Bear Rock Main to the point of connection with the Borough System, also, that the stipulation and condition, that the Borough will improve the intake so as to avoid any waste of water and also install meters on all consumer's service lines.

Section 1. Be it enacted and ordained by the Council of the Borough of Lilly, Cambria County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same: That it is the desire of Council of the Borough of Lilly to purchase the Plant and domestic system of the Summit Water Supply Company, in its entirety, including the piping system in the Borough and immediately adjacent thereto, which is used in distributing water to domestic consumers in the Porough of Lilly at the present time; the intake on Bear Rock Run, and the pipe line leading therefrom to the Borough of Lilly for a price of Forty Thousand (\$40,000.00) Dollars. Subject to approval of the Puvlic Service Commission of the Commonwealth of Pennsylvania and to the further condition that the Summit Water Supply Company, will, when the supply of the water from the Bear Rock Run intake is inadequate for the Borough of Lilly, furnish such quantities of water as may be necessary to make up the deficiency from Bear Rock or other main pipe line and the Borough to pay for this emergency supply of water at the rate of twenty cents per thousand gallons, and also, to the further sondition that the Summit Water Supply Company maintain a connection to their Bear Rock Main and install a meter, at the expense of the Summit Water Supply Company, the Borough to bear the expense of the pipe line leading from the Bear Rock Main to the point of connection with the Borough System, also the stipulation and condition that the Borough will improve the intake so as to avoid any waste of water and also install meters on all consumers service lines.

Section 2. For the purpose of obtaining the assent of the qualified electors as to whether or not Council shall purchase the plant and domestic system of the Summit Water Supply Company and pay the sum of Forty Theusand (\$40,000.00) Dollars for the same, and finance the purchase of the Plant and Domestic System by issuing bonds against the aforesaid plant and domestic system of the Summit Water Supply Company, there is hereby proclaimed a Public Election to be held on Tuesday, the eighth day of November, A.D., 1927, between the houss of seven (7) o'clock A.M., and seven (7) o'clock, P.M.? at the usual polling places for holding of General and Municiple Elections in the Borough of Lilly. The following notice of said election shall be advertised by twenty (20) hand bills posted in the most public places in the said Borough of Lilly for a period of at least thirty (30) days prior to the date of said election, for the purpose of ebtaining the assent of the Electors thereof to the connection of whether or not council shall purchase the plant and domestic system of the Summit Water Supply Company for the sum of Forty Thousand (\$40,000.00) Dollars.
