*A Resolution of the Lilly Borough Water Authority
Assuming and Accepting Ownership of the Latest
Installed Water Lines Along the Farmers
Turnpike Area in Washington Township*

WHEREAS, the Lilly Borough Water Authority (“LBWA”) owns the water mains and water systems which provide water service to the community; and

WHEREAS, the Washington Township Supervisors have requested that the LBWA “assume ownership of all of the latest installed water lines along the Farmers Turnpike area in Washington Township”. A copy of the Township’s August 18, 2023 correspondence requesting this transfer is attached hereto, marked as Exhibit “A” and incorporated herein; and

WHEREAS, Section 5613 of Pennsylvania’s Municipality Authorities Act (53 Pa.C.S. §5601, et. seq.) authorizes any municipality to convey or transfer any project or part of it to any authority; and

WHEREAS, the LBWA is willing to assume ownership of Washington Township’s project.

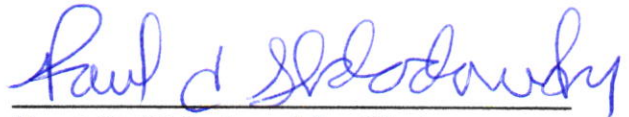
NOW THEREFORE, the LBWA hereby **RESOLVES** as follows:

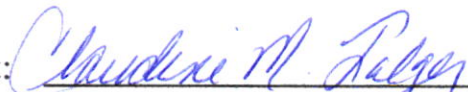
Section 1. The LBWA hereby and herein assumes ownership of the latest installed water lines along the Farmers Turnpike area located in Washington Township.
